Subject: Recognition of MBBS degree (150 seats) granted by Dr. Shakuntala Misra National Rehabilitation University, Lucknow in respect of the students being trained at T S Misra Medical College & Hospital. Amausi, Lucknow - Appeal.

Sir,

In continuation to UGMEB's letter dated 15.05.2023 on the subject cited above, I am directed to say that your appeal filed before the Appeal Committee under the Chairmanship of Chairman, National Medical Commission was heard on 09.06.2023.

2. After hearing the submission made by the college authorities and verification of the facts, the Committee granted Recognition of 150 MBBS degree seats to the institute for five (05) years. Copy of the order dated 30.06.2023 is attached herewith.

3. In view of the above, the Recognition is granted of MBBS degree when awarded on or after Jan, 2023 by Dr. Shakuntala Misra National Rehabilitation University, Lucknow in respect of the students being trained at T S Misra Medical College & Hospital, Amausi, Lucknow with an annual intake of 150 MBBS students under the following terms & conditions, as contained in the Gazette Notification No. MCI- 34(41)/2010-Med./3491. dated 16th April, 2010 titled "Establishment of Medical College Regulations, (Amendment), 2010:

- (i) The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.
- (ii) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (iii) Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.

4. This approval for Recognition/ Approval of (150 seats) is granted subject to applicability of amendments in MCI/NMC Regulations from time to time.
